

# **Rules for using the information portal Insurance-Ukraine.com, (hereinafter - Privila)**

## **1. Basic terms**

**1.1.** Website (Information Portal) - a set of files placed on the network, united by the address space of the domain [www.insurance-ukraine.com](http://www.insurance-ukraine.com).

**1.2.** Site User (User) - any person who communicates and/or acts on the site and thereby automatically confirms full agreement with the provisions of these Terms.

**1.3.** Site Administration (Administration) - WELCOME TO UKRAINE LIMITED LIABILITY COMPANY, which owns all property rights to the site and which administers it.

**1.4.** Content - any information-relevant content of the information resource, including in the form of texts, figures, photos, videos, graphics, news, and other materials.

## **2. Rights and responsibilities of the Administration and site moderators**

**2.1.** The Administration has the right to change the design of the Site and its content at any time and without notice.

**2.2.** The Administration has the right to send Users by e-mail and/or other means of communication messages related to the use of the Site.

**2.3.** The site moderator, appointed by the Administration, monitors and takes the necessary measures to ensure that the content posted on the Site corresponds to the theme of the Site. The Moderator and the Administration of the Site make every effort to exclude from the Site careless, inaccurate, offensive information, inaccurate information, or knowingly incomplete information.

**2.4.** The Administration of the Site may use the personal data of Users to contact these Users, for example, but not exclusively, to notify about changes and/or updates of services offered by the Site, and/or to send important and similar messages, and/or for the purpose of sending notifications concerning the products made by the User on the Site, and/or for contacting the User related to the service of such User, and/or for informing the User about promotions, discounts and exclusive offers of the Site.

## **3. Rights and obligations of the User**

**3.1.** The User has the right to use the information and functionality of the Site and contact the Administration of the Site to resolve disputes.

**3.2.** The User is obliged to publish (post/copy) the information posted on the Site with a mandatory link to the information portal [Insurance-Ukraine.com](http://Insurance-Ukraine.com).

## **4. Responsibility**

**4.1.** Articles, information, and other content posted on the Site are informational and are not a recommendation and/or incentive for users to invest money and can not be considered as an incentive to take certain actions.

**4.2.** The Site Administration is not liable to the User or any other third parties for any damages, including lost profits or lost data, damage to honor, dignity, or business reputation caused in connection with the use of the Site.

**4.3.** The site administration is not liable to the User or any other third parties for the consequences of the use of information used/received by the User on the Site.

**4.4.** The Administration provides the content of the Site exclusively for informational purposes and claims regarding the improbability or erroneousness of calculations, statements, and conclusions may be of a recommendatory nature only.

**4.5.** All proposals, intentions, approvals, and any other statements/appeals cannot be considered as a public offer.

## **5. Agreement on confidentiality and storage of personal data**

**5.1.** Collection, storage, use, processing, disclosure of information received by the Site Administration as a result of visiting the Site and/or filling in registration forms, applications, orders, including personal data of Users, is carried out by the Site Administration in accordance with the current legislation of Ukraine. The User acknowledges and consents to the collection, processing, storage, use, and disclosure of personal data by the Site Administration within the framework and for the purposes of this Agreement and undertakes to notify the Site Administration in writing of its desire to exclude personal data from the Site.

**5.2.** In case of registration on the Site and/or filling in applications/registration forms / orders, etc. for registration of financial products of Insurance Companies, personal data may be transferred to the following third parties:

5.2.1. Insurance-Ukraine.com visit statistics collection systems;

5.2.2. Banks;

5.2.3. Insurance companies represented on the Site;

5.2.4. Insurance agents.

**5.3.** Collection, storage, use, processing, disclosure of information received by LIMITED LIABILITY COMPANY "WELCOME TO UKRAINE" as a result of visiting visitors to its sites and/or filling out registration forms, applications, orders, including personal data of users. legislation of Ukraine.

By agreeing to the rules of use of the Information Portal, the User agrees to voluntarily pay the service fee for processing his application form, personal data, as well as their storage and transfer of data only to persons specified in paragraph 4.2. of this Agreement in the amount of 8%.

*The User's use of the Insurance-Ukraine.com information portal means that the User understands and accepts all the above provisions of the Rules.*

The site administration reserves the right to make changes to the text of these Rules, which take effect from the moment of their publication on the information portal Insurance-Ukraine.com. Further use of the Site after making such changes means the User agrees with them.*
